1. THE PARTIES

Hereinafter, "EKO MMI Fuarcilik Limited Sirketi" shall be referred to as "EKO MMI" and the company that will exhibit at logitrans International Transport Logistics Exhibition (hereinafter referred to as "Exhibition") by signing the present "Exhibitor Participation Contract" shall be referred to as "Exhibitor". Both parties agree to fully respect the Participation Contract.

2. DEFINITION

WTCI: World Trade Center Istanbul (WTCI) is the principal service supplier of the exhibition as the owner of the fairground. The conditions of the ground lease agreement directly related with exhibitors are passed on to this contract in extenso.

LOCATION AND DURATION

- 3. 3.1. The location of the exhibition is "Istanbul Expo Centre". However, in case of events beyond its control, natural disasters and other legally acceptable force majeure cases, EKO MMI shall be entitled to change the venue and the dates of the exhibition. EKO MMI shall also be entitled to change the general layout of the exhibition areas and projects.
- 3.2. The present contract shall enter in force as of its signature. It shall expire at the closing date of the exhibition, provided that the exhibitor meets all their obligations by that date. In the event whereby the exhibitor does not meet all their financial and administrative obligations by the closing date of the exhibition, the contract shall expire at the date of completing of all their financial and administrative obligations.
- 3.3. By the closing of the exhibition, the exhibitor agrees to discharge EKO MMI from all its obligations. **DEFINITION OF THE SERVICES**

- 4.1. During the exhibition, EKO MMI shall provide its exhibitors the following services against the participation fee (The price for a unit area of one square meter x square meters rented).
 - a. Allocation of space at the exhibition area
 - **b.** Overall promotional services
 - Information services at the entrance gates
 - d. Security services at the common exhibition area (In-stand security services are at exhibitors' responsibility)
 - e. Cleaning services at the common exhibition area (In-stand cleaning services are at exhibitors' responsibility)

 f. Exhibitor passes for the stand attendants. Details stated in Article 6.5.
- 4.2. Any additional services other than those mentioned in the Participation Contract required by the exhibitor shall be requested in writing and are invoiced separately.

STAND CONSTRUCTION PRINCIPLES

General principles for stand construction

- The exhibitor that has the taller of two adjacent stands must cover 5.1.1. the side of adjacent to the neighboring stand with a separation material that is compliant to health and safety standards. The exhibitor must not violate the rights of third parties when doing so. The rear side of the walls of the constructed stand must be of a neutral design, white, smooth and clean. Only such materials as are opaque and impervious to light are permitted for this purpose
- 5.1.2. Suspensions of stand elements or exhibits are not permitted. Stand elements and exhibits must be independently secured.
- All set-ups in the fover shall be subject to special fee, permission and conditions. Only disassembled booths may be set up at the foyer area and any construction hindering the fire cabinets and corridors must be avoided. Use of any kind of paints or thinner is prohibited. No drywall, steel, painted wood, iron or similar construction works shall be allowed in the foyer area. Instead, aluminum alloyed metal or non-painted construction works are allowed. If these terms are violated, a fine of 250 Euro + VAT per square meter shall be charged. During the works to set up aluminum alloyed metal construction based booths, welding, hewn stone and similar construction works shall not take place inside the foyer area and this kind of preparatory works shall be completed out

of the foyer area. The exhibitor shall take necessary measures during the transport and construction phases in order to avoid any damage to the floor during assembly works. Moreover, the stand shall be set up on an elevated wooden / laminated bedplate. In case the bedplate is not constructed, no stand set-up in the foyer area shall be permitted. The exhibitor shall cover all losses that may arise during the set-up and dismantling works of the exhibitor's stand in the foyer area as well as other works and actions in relation to the said stand and/ or due to failure to comply with rules. Weight of the goods (machines, equipment) to be exhibited in the fover area shall not exceed 500 kg (five hundred kg) per square meter. Exhibition of any goods above that weight as well as heavy-tonnage machinery and similar items shall not be allowed in the foyer area. In circumstances that EKO MMI deems necessary, it shall be entitled to see the weighbridge receipts of the products to be exhibited, and upon request, the exhibitor is required to immediately present the said receipts. The exhibitor shall not be allowed to carry out works in its stand in the foyer that would interrupt security measures. The elevation of the stands to be set up in the foyer area shall be maximum 2.60 meters. Stands shall not block the visibility areas of security cameras nor shall they block access to fire cabinets and they shall not be designed in a manner to obstruct ventilation holes. There are no water or air system in the foyer area and it is forbidden to sell goods in the foyer area. The exhibitor shall be obliged to submit the certified ground plans (layout plans) and technical details of the goods to be displayed in the foyer area to EKO MMI at the latest 6 (six) weeks in advance prior to the stand set-up date. These plans shall be approved by EKO MMI. In case ground plans are not submitted on a timely basis or are not approved by EKO MMI, the Exhibitor shall not be permitted to have access to the exhibition area.

Stand construction principles for construction by exhibitors 5.2

- 5.2.1. The exhibitor who signed 'Space Only' Contract, is obliged to have their stand constructed provided that they will bear the entire re sponsibility and have the internal decoration expenses met on their own account. The exhibitor may work by a supplier of their own choice (hereinafter referred to as the "contractor"). The exhibitor who signed 'Space Only Contract' is obliged to inform EKO MMI within the given time, about electricity need for their stand with the relevant form on the official web site. Otherwise electricity shall not be provided on the stand area. The exhibitor must inform the contractor of all relevant clauses of the contract. EKO MMI shall be entitled to stop activities of contractors acting in violation of the contract.
- **5.2.2.** The maximum allowed height for stand construction is 5.00 meters. There is height restriction of certain areas inside the halls. The approval must be obtained from EKO MMI about the stand height. Weight of products to be exhibited (machinery, tools etc.) shall not
- exceed 2,250 kg (two thousand two hundred fifty kg) per square meter.

 5.2.3. The stand design concept should conform with the type of stand rented (island, end, corner or row stand). To maintain the exhibition's character as a communications platform and business exhibition, exhibitors must make sure that their stands have an open design. EKO MMI is entitled to prescribe changes in stand design in connection with this.
- 5.2.4. The stand design shall include the stand number of the area provided to the exhibitor by EKO MMI. The stand number shall be placed on each open side in a way that it is visible to visitors.
- Stand design can only be approved if the open sides of the stand have a uniformly open design. Erecting closed walls is permitted, provided they do not take up more than 70 % of the stand side in question, and completely closed walls may be no more than 4.00 m in length. A closed length of wall measuring 4.00 m must be followed by an opening at least 2.00 m wide. This ruling does not apply if the wall concerned is set back from the stand perimeter by at least 2.00 m. EKO MMI reserves the right to permit exceptions to these guidelines in individual, well-founded cases.

- **5.2.6.** Advertising hoardings that extend above the walls of the stand must be at least 2.00 m away from the immediately adjacent stand. Advertising may not feature flashing or alternating lights. The stand design must not be extended over the aisles. EKO MMI reserves the right to allow exceptions to this ruling in individual.
- The exhibitor must have the architectural designs of the intended stand construction approved by EKO MMI on the date specified in the time schedule. Otherwise, construction of the stand will not be allowed. EKO MMI is entitled to inspect whether or not the project is in conformity with the general structure, to propose changes, or to reject it. EKO MMI is also entitled to request additional stand drawings and technical calculation by a licensed civil engineer if the stand construction is two floor or the design in a way that calculations may be needed for safety and security purpose.
- **5.2.8.** The exhibitor may unveil its stand after the completion of necessary controls and the approval from EKO MMI prior to the opening of the foyer. It is forbidden to unveil a stand before an approval is obtained. Otherwise, the exhibitor agrees to pay a fine of 1,000 (one thousand) Euros + VAT per sqm of the stand. It is mandatory to provide protection for power supply units which are drawn from the walking halls and remain exposed inside the stand. Otherwise, no power supply will be allowed to the stand. Panel, fuse, and residual current relay are strictly required to be installed in all stand connections. No power shall be supplied to connections without panel, fuse, and residual current relay and any power that is already on shall be turned off.
- **5.2.9.** The parcel to be allocated to the exhibitor without stand construction shall be delivered by EKO MMI to the exhibitor or their designated contractor with a number and the corners marked by color paint, as is indicated in the time schedule (Art.9)
- **5.2.10.** The exhibitor and/ or its contractor may not carry out preparations for its own stand beyond the area that is allocated to it. In case spaces beyond the stand area are occupied by means of materials, devices etc. or set-up/ preparatory works and stand set up works take place in those spaces, it shall be obliged to pay a sum of 250 Euros + VAT per sqm for the occupied space.
- 5.2.11. The exhibitor is obliged to complete their stand construction and the internal decoration by midnight, the day before the opening date of the exhibition.
- $\textbf{5.2.12.} \ \textbf{Upper storey stand space costs 50\% of the price of the respective}$ ground floor space. Each additional square meter of stand space or part thereof will be charged in full. Two storey exhibition stands have to be approved by a licensed civil engineer and submitted to EKO MMI no later than 6 (six) weeks before exhibition date. Additional contract has to be signed for the upper storey installation.
- **5.2.13.** When setting up the stand, both exhibitor and its selected contractor must abide by the general security and cleaning rules. They are not allowed to carry out any kind of work which hinders the operation of systems for supplying water, electricity, compressed air, communication line, wastewater circuit from the channels situated at the base of the fairground.
- **5.2.14.** Under no circumstances, may the aeration of fire cabinets and emergency evacuation exits be obstructed. During stand construction, electricity, water, telephone and fixed socket distribution boxes for air shall be left open and shall not be covered.
- **5.2.15.** For works that may affect architectural, electrical or mechanic systems in the building, authorization must be got from EKO MMI. All kinds of work lacking EKO MMI's information and approval shall be immediately prevented and all related loss and damages shall be charged to the exhibitor.
- Project applications for standard stand constructed by EKO MMI 5.3. or its partners
- The exhibitor may ask EKO MMI to be in charge of the construction of their stand against payment. EKO MMI shall meet such requests 5.3.1. within the framework of the Participation Contract.
- "Standard Stand" constructed by EKO MMI is a 3 meters high structure in the desired dimensions, with aluminum profiles, white wooden separation panels and upper junction profiles with or

without separation, having 75 watt light for every three square meters, displaying the logo of the company on the front of panel. Full Service Package stand is a 3 meters high construction with aluminum panels in the requested design standard, rail cargo Turkey, air cargo Turkey or national (Country). White wooden separation panels and upper junction profiles with or without separation, having 75 watt light for every three square meters, displaying the logo of the company on the front of panel. There are 3 packages of Full Service Package. The 12-18 sqm stand package includes 1 storage room 1m x 1m, 1 table, 4 chairs, 1 brochure rack, 1 bar stool, 1 counter,1 wastepaper basket, daily stand cleaning, 5 exhibitor passes and premium catalogue package. The 20-27 sgm stand package includes 1 storage room 1m x 1m, 2 tables,8 chairs, 2 brochure rack, 1 bar stool, 1 counter,1 wastepaper basket, daily stand cleaning, 10 exhibitor passes and premium catalogue package. The 28 sqm and above stand package includes 1 storage room 1m x 1 m, 3 tables, 12 chairs, 3 brochure rack, 2 bar stool, 1 counter, 1 wastepaper basket, daily stand cleaning, 15 exhibitor passes and premium catalogue package.

- 5.3.3. The exhibitor must submit their written request for standard stand construction to EKO MMI at least 15 days prior to the opening date of the exhibition. Any request submitted later than the said deadline will be met as per the evaluation by EKO MMI of the factors restraining the material and service supplies.
- **5.3.4.** EKO MMI shall deliver the standard stand to the exhibitor as indicated on the time schedule (Article 9). The exhibitor is obliged to have the stand delivered EKO MMI, ready for the exhibition as indicated on the time schedule (Article 9).
- The exhibitor is not allowed to make perforations, drive nails, paint, or stick things with glue in the stand area, on the aluminum profiles and wooden panels or use any kind of adhesive other than double sided/non marking ones. Any damaged material will be invoiced to the exhibitor.

6. 6.1. **ADMINISTRATIVE PRINCIPLES**

- The exhibitor acknowledges and undertakes not to exhibit any product other than the scope of the exhibition, the list of which is a part of to this contract.
- Product exhibitions and/ or banners, flags or posters shall not be permitted in the exhibition area without the approval of EKO MMI. In case of unpermitted applications, a daily fee of 1,000 (one thousand) 6.2. Euros plus VAT shall be invoiced to the exhibitor for each such material.
- 6.3. The exhibitor may neither allow the area allocated to them to be used by third parties, nor rent or assign it to any third parties for any reason whatsoever, in part or in full.
- 6.4. As of the opening of the exhibition, the exhibitor shall have an attendant present at the stand every day during the visiting hours and the attendant shall leave the stand by the closing hour. Delivery and removal of goods to/from the stand are forbidden during the visiting hours of the exhibition. If the exhibitor leaves the stand alone or dismantles earlier as indicated on the time schedule (Article 7), EUR 500 is charged to the exhibitor.
- Two exhibitor passes shall be provided to the exhibitor for the first ten square meters of the stand rented. An additional exhibitor pass 6.5. shall be provided for every additional ten square meters. Exhibitor must submit their requests for additional exhibitor passes with the relevant form on the official web site within the given time.
- When constructing the stand and disposing the goods to be displayed, the exhibitor must comply with the conditions related to 6.6. the height limits and the height restrictions in between the halls.
- Other than the assembly of the construction, any dangerous or environmentally harmful applications such as cutting of raw materials, use of point gun, large scale welding are forbidden in the exhibition area. Other than for carried the schibitor shall 6.7. construct a shipboard base before covering the floor of their stand.
- 6.8. The exhibitor can rent additional goods and services from EKO MMI. Any such material rented must be returned to EKO MMI authorities in the same conditions as delivered. Any damaged material will be invoiced to the exhibitor.

- 6.9. The exhibitor shall inform EKO MMI authorities about any emergency needs for additional services. EKO MMI shall do their best in order to meet these requests on the spot. In the event of non available goods and services exhibitor shall be informed about whether or not the request can be met as well as the time necessary to provide the requested services, and their approbation shall be asked.
- 6.10. During the exhibition, cleaning services for common exhibition area will be provided by EKO MMI. In-stand cleaning services fall outside the scope of this service. Upon demand by the exhibitor, special stand cleaning services shall be provided by EKO MMI against a fee. It is forbidden to hire cleaning services from external parties. The exhibitor is obliged to take all waste other than domestic garbage out of the exhibition area. In the event whereby this condition is not met, EKO MMI shall be entitled to transfer the waste by itself and invoice the exhibitor.
- 6.11. The visitors will be able to visit the exhibition within the dates and hours specified in the time schedule. In case of necessity, EKO MMI shall be entitled to change the visiting hours, provided that information is provided thereof. Visitors shall pay an entrance fee unless otherwise is decided by EKO MMI.
 6.12. The exhibitor must inform EKO MMI officials for all visual and
- 6.12. The exhibitor must inform EKO MMI officials for all visual and acoustic activities that they intend to present in exhibition area, in writing, at least 30 days before the opening date of the exhibition. During such performances, the exhibitor shall avoid creating any disturbance for other exhibitors. EKO MMI shall be entitled to refuse activities which are out of the scope of the exhibition project and are likely to create problems for EKO MMI and other exhibitors, either for security reasons or due to the way of their application.
- 6.13. During the promotional activities, the sound level shall be set in order not to exceed 70 dB within the limits of stands. Any exhibitor failing to fulfill this obligation will be warned by EKO MMI authorities. In the event whereby the warning is not heeded within five minutes, the electric power of the stand shall be cut for two hours. The exhibitor shall be responsible for all damages related to such a power cut.
- 6.14. EKO MMI shall provide security service in the common exhibition area. EKO MMI does not provide any insurance service for the material and the products of the exhibitor and for the workers and their personal belongings. It cannot be held responsible for any loss and damages related to these matters. The exhibitor personally bears any such responsibility. Therefore it is recommended that the exhibitor insures themselves, their personnel as well as material and goods exhibited, against all risks.
- **6.15.** In accordance with the properties of the goods exhibited, the exhibitor may take their own security measures. Any exhibitor using private security services must inform EKO MMI authorities there of and provide information related subcontractor, in writing, at least 3 days before the opening date of the exhibition. EKO MMI shall be entitled to refuse the exhibitors' security if they are below its own quality standards.
- **6.16.** Bringing in and exhibiting all kinds of inflammable, radiating, explosive, nuclear, biological and chemical material at the exhibition site are forbidden. The fuel tanks of all vehicles to be exhibited must be kept empty during the whole exhibition period.
- 6.17. EKO MMI shall be entitled to intervene immediately and at any stage against any activities outside of the provisions of the present contract and the related TOBB (The Union of Chambers and Commodity Exchanges of Turkey) regulations. In case of failing to comply with the contract, the exhibitor shall be responsible for all damages due to such an intervention.
- **6.18.** EKO MMI shall be obliged to take out a third party liability insurance which is strictly required by TOBB. Its liability towards third parties shall be limited to this insurance. The exhibitor agrees in advance that it shall be directly liable for all losses and damages to EKO MMI and third parties which may be caused by it and its personnel as well as any party ordered or instructed by it.
- **6.19.** EKO MMI shall not assume any liability in connection with the dis

- played products, stand materials and belongings of stand personnel. Any and all materials, objects, tools, instruments and similar movable properties of the Exhibitor, its personnel or its related parties shall be protected by all necessary measures to be adopted by the Exhibitor and the Exhibitor agrees in advance that EKO MMI shall have no responsibility in this respect. The Exhibitor shall be obliged to take out anexhibition insurance for all these items and to adopt all security measures for the protection of the goods stated in this paragraph. The Exhibitor shall bear the entire liability arising from its failure to take out insurance and to adopt necessary security measures.
- 6.20. EKO MMI as well as the two joint venture companies EKO Fuarcilik Ltd Sti and Messe München Gmbh may use exhibitor company name and exhibitor product groups information and exhibitor company/brand logos to be published in social media and other electronic and printed media for the promotion campaign of logitrans exhibition worldwide.

7. LIABILITY

- 7.1. The Exhibitor agrees that it shall be liable for all losses that EKO MMI, its personnel, the exhibition organizer, their contractors and visitors as well as any other third party may suffer, that may be inflicted by either itself or its personnel or its contractor's personnel as well as other persons that are present in the exhibition ground due to the Exhibitor, and that it shall be obliged to cover all losses and damages in this respect. If EKO MMI pays damages or any other sum due to such losses referred to in this Article, the Exhibitor agrees and undertakes that EKO MMI may have recourse to it for the redress of its losses and that it shall indemnify EKO MMI against all its such losses upon EKO MMI's first demand.
- 7.2. The Exhibitor shall be liable for any loss and damage that it, its personnel, its contractor's personnel or any other parties who are present in the exhibition ground due to the Exhibitor, may cause or give to such space allocated to the Exhibitor in the exhibition ground, and the exhibition's car parking lot, lavatories, restaurant spaces, halls, foyer area and other similar areas of common use as well as physical equipment and assets deployed in those areas, and mechanical and electrical systems and fire alarm/ detection systems and PA systems. Upon EKO MMI's first demand, the Exhibitor shall be obliged to reimburse EKO MMI the costs of such missing, damaged, broken-down parts that shall be determined in the "Report" to be issued by EKO MMI.

WORK SAFETY

- 8.1. The Exhibitor shall be obliged to employ only insured personnel in the exhibition ground which is called "Leased Site" which it shall use pursuant hereto as well as all its annexes and outbuildings, and it shall be further obliged to procure that its personnel shall be working in a safe and secure environment as required by the applicable legislation; to fully adopt all measures; to provide and distribute to its personnel protective materials; to recruit and train its own personnel or its subcontractor's personnel according to the provisions of the applicable legislation and to supervise and keep them under its control. The Exhibitor shall be obliged to deliver the name list of its entire personnel and its contractor's personnel, to EKO MMI by the date indicated in the time schedule and without any further need for EKO MMI's demand, including such certificates that its personnel should have under the Law no 6331 particularly in connection with occupational safety and health training courses as well as occupational and professional competency training certificates, and the Exhibitor shall be obliged to comply with the Occupational Health and Safety Legal Compliance Procedure which is executed and attached hereto. In this respect, the Exhibitor agrees that EKO MMI shall be authorized to audit the Exhibitor pursuant to the Occupational Safety Law no. 6331 and other applicable law.
- 8.2. The Exhibitor shall be solely obliged to ensure that its personnel as well as all workers to be employed in the exhibition and in connection with the erection of exhibition stands shall act in compliance with occupational health and safety rules as well as such worksite safety

rules, directives, regulations and orders that EKO MMI may impose in this respect. The Exhibitor shall be solely liable personally and financially to indemnify any loss and damage that may be caused to any and all vehicles, equipment and goods that may arise from the acts by or the failure of its personnel to comply with established rules relating to occupational health and safety and other necessary worksite safety and administrative issues.

- The Exhibitor shall be liable personally and financially to bear all 8.3. criminal liabilities as well as to indemnify all pecuniary and non-pecuniary damages and all claims arising from death, physical injury, sickness, incapacity to work, loss of support and all similar claims, which shall be attributable to any and all accidents and occupational accidents that may happen in the Leased Site in the course of the contractual works or that involve the Exhibitor's personnel or its subcontractor's personnel and that may cause damages to the Exhibitor's personnel (or its subcontractor's personnel) or EKO MMI's personnel or to third parties. The Exhibitor shall be obliged to indemnify such damages.
- The Exhibitor shall cover any and all healthcare expenses (including 8.4. hospitals, doctors, surgical operations, ambulance and medicine) in case of any occupational accident that is attributable to the negligence or fault on the part of the Exhibitor's personnel and its subcontractor's personnel. EKO MMI shall reserve its right to have recourse to the Exhibitor on account of all fines, penalties, damages and other financial liabilities that it shall be obliged to pay in this respect, and the Exhibitor accepts EKO MMI's recourse right in this respect.
- 8.5. In case EKO MMI is directly held liable or charged with a liability jointly with the Exhibitor for any reasons arising from the obligations of the Exhibitor's personnel or its subcontractor's personnel or third parties under the Labor Code or other applicable legislation and therefore EKO MMI is obliged to make any payment to the Exhibitor's personnel or its subcontractor's personnel or third parties, the Exhibitor agrees and undertakes to indemnify EKO MMI against its such loss in cash and in lump sum and without any need for any notice, together with such interest that shall accrue thereon at a rate of 10% per month and shall be accrue from the payment date.
- 8.6. . The Exhibitor shall be obliged to take all measures in full that would ensure the safe and secure working and employment of its workers, contractors and subcontractor workers to be engaged in the leased area; to recruit, supervise and employ the workers in line with the applicable legislation. The Exhibitor shall be obliged to take all safety measures as may be required by the entire applicable legislation so that its workers and other technical personnel in the contractual exhibition ground shall not have any accident; to get, procure and deliver protective equipment to the workers and to constantly control if such equipment is used during the entire course of works.
- 8.7. It is obliged to operate in accordance with the work safety regulations during all modification and maintenance works during stand construction, dismantling and operating periods and to take all measures against special risks for applications like working at high levels or with electricity. All measures that are advised by the workers of IDTM, Occupational Health and Safety company and EKO MMI shall immediately be taken by the Exhibitor.
- 8.8. Where the Exhibitor acts in breach of any of its obligations under this article, EKO MMI shall have the right to immediately terminate this Contract. Upon such termination, all rental sums paid by the Exhibitor shall be recorded as revenue as a penalty clause. The Exhibitor agrees to this in advance. EKO MMI shall also have the right to deny access to the Exhibitor's or its subcontractor's personnel to the Leased Site unless their names are duly notified to EKO MMI. The Exhibitor may not claim that it has suffered a loss on account of such denial and shall in no event assert any claim for damages under any name whatsoever.
- Without being limited to those ones listed herein, the Exhibitor 8.9. agrees that it shall be obliged to submit to EKO MMI all documents

issued under the Occupational Safety and Health rules as defined herein and in the Law; to deliver to EKO MMI its own documents and information that should be obtained by means of its own Occupational Health and Safety specialist; to audit if subcontractors engaged in stand erection works comply with this Contract, applicable laws and Occupational Safety and Health regulations; to procure that all processes and works in the exhibition ground, including transportation, erection, set-up and any preliminary preparatory works shall be carried out in line with Occupational Health and Safety services; to audit its employees; to take all measures that may be necessary or are notified by EKO MMI to facilitate the works of occupational safety and health specialists at the site; to ensure that no one who is not related to works or who lacks any occupational safety and health training in this work and work field shall be admitted to the leased site, to provide its workers who shall work in stand erection as well as during works thereafter, with such colored attire/ vests etc. depending on their profession, and to take and develop such and similar facilitating measures.

CONDITIONS AFFILIATED TO WTCI CONTRACT

- 10.1. At the end of the exhibition, the exhibitor must take all their exhibited goods, their stand construction materials, additional equipment and waste out of the exhibition center in accordance with the time schedule at Article 9. In the case that the exhibitor does not move out the materials until dismantling deadline, they agree to pay 8.000 TL (eightthousand Turkish Liras) +VAT per each passing hour. In the event whereby this obligation is not met, EKO MMI shall be entitled to take such material out of the exhibition center itself and invoice the exhibitor of the expenses thereof. The exhibitor shall be responsible for any loss and damage that may occur in such an event. Catering services have to be obtained from WTCI. It is strictly forbidden to hold activities by the name of 'collective food distribution' or 'free food and beverage distribution' etc. either at the stands or other places, during the organizations. The treats that are allowed at exhibitor booths to be brought by exhibitors are defined as sweet-salted cookies, nuts and chips, sweets and desserts, (such as Turkish baklava) small canapé, cold and hot (non-alcoholic) drinks.
- It is forbidden to have food delivered to the exhibition area from outside and to offer or sell alcoholic beverages in the stand areas, including cocktail organizations and catering companies. The Exhibitor who acts in contrary to this rule shall be imposed a penalty clause in the amount of 100.000 TL (one hundred thousand Turkish Liras) +VAT.

- 10.3. The Exhibitor may not offer, distribute or sell tobacco and off-license products in both the leased areas and beyond those areas as well as in car parking lots. It may not erect booths or stands nor may it make any sales and/ or distribution for these purposes at any place(s). In case any breach of this provision is discovered, the Exhibitor shall pay a penalty clause of 10,000 TL (ten thousand Turkish Iira) plus VAT. Moreover, the relevant stand shall be immediately removed by EKO MMI.
- 10.4. The exhibitor is liable to pay their expenses of electricity, water, natural gas and/or telephone usage as well as the identified mal function and repair costs related to damage given by the exhibitor or their contractors at the end of the exhibition. The exhibitor shall order the electricity, water and natural gas demands to EKO MMI on payment through the forms on the official web site of the exhibition within the given time.
- Maximum 15 KW power can be obtained from the outlet boxes 10.5. below the stands. Total power capacity of a single hall is 400 KVA. If more amount of power is needed, it is necessary that the exhibitor brings generator to the fairground to run during the exhibition.
- 10.6. In case WTCI fails to perform its obligation in case its rights related to the leased site are restricted due to legal requirements or court orders and EKO MMI fails, in turn, to perform its obligations arising from the Exhibitor's contract, the Exhibitor hereby agrees and undertake in advance that it shall not claim any damages from EKO MMI. **TERMINATION, CANCELLATION POLICY AND PENALTY CLAUSES**
- 11.
- 11.1. If the location, type, dimensions or size of the exhibition area rented the exhibitor are subsequently changed to the extent that the exhibitor can no longer be reasonably expected to accept the exhibition area, the exhibitor is entitled to withdraw from the rental contract within one week of receiving written notification by EKO MMI. Otherwise, apart from his statutory rights to withdraw from the contract, the exhibitor has no right to withdraw from this contract. Should the exhibitor declare their withdrawal from the given event, EKO MMI is, irrespective of whether the exhibitor concerned has the right of cancellation, entitled to otherwise dispose of the rented space.
- Any exhibitor cancelling their participation without being entitled 11.2 to do so and, as such, defaulting on fulfillment of contract without good reason, is to pay EKO MMI the entire participation fee in full if the stand space is left empty during the event or even if EKO MMI is able to re-let the space concerned; in the latter case, however, EKO MMI is to offset the value of the expense saved and the advantages it has gained as a result of re-letting or otherwise using the given stand space. In addition to re-letting the stand space to another exhibitor, other usage thereof may also and above all involve EKO MMI transferring its usage to a third party who would otherwise have been placed elsewhere to avoid giving the impression of a gap in the stand arrangement or re designing the stand space to conceal the fact that is not occupied. To the extent that EKO MMI re-lets the stand space to another exhibitor, who would otherwise have not been placed elsewhere, the exhibitor must pay 50% of the agreed participation fee as flat-rate compensation for expenses incurred by EKO MMI because the exhibitor withdrew from the contract without being entitled to do so. EKO MMI's right to claim further damages remains unaffected. The exhibitor can demand that the flat-rate compensation be reduced if he proves that EKO MMI has incurred fewer expenses.
- 11.3. EKO MMI is entitled to withdraw from the contract if the exhibitor fails to meet their financial obligations to EKO MMI on time, EKO MMI has extended the deadline by 5 days and this deadline for payment has not been met. This applies especially if the exhibitor is in default of payments for the projected participation price. If the exhibitor decides to withdraw after 11th September 2020 he is liable to pay the 100% (one hundred percent) participation fees. EKO MMI is also entitled to withdraw from the contract if the exhibitor neglects their duty arising from this contract to respect EKO MMI's

- rights, objects of legal protection and interests and EKO MMI can no longer reasonably be expected to adhere to the contract. In the aforementioned cases, EKO MMI is entitled not only to withdraw from the contract but also to demand from the exhibitor the agreed participation fee as flat-rate compensation. EKO MMI's right to claim further damages remains unaffected The exhibitor can demand that the flat-rate compensation be reduced if he proves that EKO MMI has sustained less damage.
- Where the Exhibitor fails to fulfill any of its obligations agreed herein on a timely basis or in full, or its acts cause a damage or loss 11.4. to EKO MMI, EKO MMI shall have the right and power to unilaterally terminate this Contract provided that its right to claim all its losses and damages shall remain reserved.

12. FINANCIAL PRINCIPLES

- In the event whereby an exhibitor fails to fulfill any of their payment obligations, EKO MMI shall be entitled to terminate the present 12.1. Contract unilaterally and to claim any damage it would suffer.
- The deadlines for payment given in the notice of admission or the invoice must be observed. All invoiced amounts in all EKO MMI 12.2. invoices, which are connected with the event, must be transferred in EUR, without deductions and free of all charges to the account specified in the respective invoice. Payment deadline is 30 days after the issuing date of the invoice. For invoices issued after September 4, 2020 payments are due immediately. The invoices will be sent on the date of issue first by e-mail and then by post. The exhibitor must present proof of payment via cheques, and the proof of cash payment by a receipt or bank deposit note. Prior payment in full of the amount invoiced is a condition for access to the exhibition area, an entry in the catalogue, and the provision of exhibitors' passes.
- Shall one payment in stall ment be defaulted, the remaining in stall ment 12.3. become payable immediately. Standard monthly default interest for payables in T.L. will be 4%, and the monthly interest for Euro will be 0.8%.
- EKO MMI shall pay the stamp duty arising from this Contract. 12.4.
- 12.5. In the event whereby the exhibition cannot be opened, EKO MMI shall reimburse the fees it has received to the exhibitor. Its responsibility shall be limited to this amount.

13. **FORCE MAJOR EVENTS**

In case any force major event, including general strikes, state of war, civil war, acts of God, fire, terrorism acts and similar events as defined in the applicable law, the Exhibitor may not assert any claim for loss and damage against EKO MMI.

14. NOTICES

Any and all notices that the Parties may exchange hereunder shall be sent to their respective business addresses set out herein in writing unless otherwise is agreed. Notices shall be deemed to have been served on the date of their delivery. Parties shall inform any change of address to each other at the latest within 5 (five business days. Unless the new address is notified, the notices and correspondence to be served on the former address shall be deemed valid and effective.

DATA PROTECTION AND SHARING 15.

In compliance with data protection laws in Turkey, the personal data of the exhibitors are processed and used for fulfilling the business purposes of the company and is shared with third parties in order to fulfill the purposes of the contract. Company data of the exhibitor shall be used by third parties for marketing purposes of related trade fairs or marketing services by EKO MMI; EKO Fuarcilik Tic. Limited Sirketi, Messe München GmbH and the associate companies e.g. international representative network.

16. EFFECTIVENESS AND SETTLEMENT OF DISPUTES

- 16.1. In case of dispute, the Courts and Execution Offices of Istanbul shall have jurisdiction.
- 16.2. This contract is subject to the law of Turkey
- 16.3. The present contract consists of 16 (SIXTEEN) articles and their paragraphs. Written forms and documents mentioning the additional requests of the exhibitor are integral parts of the present Contract.
